

Ekal Vidyalaya aims to impart basic education to children of remote areas and inculcate human values in them. The purpose is to turn these children into 'change leaders' in their families and communities by spreading the importance of education, removal of social evils like alcoholism, encouraging environment conservation by tree plantations, inculcate sensitivity towards maintaining the village surroundings clean and hygienic. Its achievements are impressive – more than 70,000 schools and about 2 million students across India, and a dedicated army of teachers and 70,000 + volunteers. Its administration and operational costs are no more than 8% because nearly everyone involved with the effort devote their time voluntarily.

# CIF's Higher Education Forum in India 16 & 17 January 2019

Canada India Foundation's Higher Education Forum held in July 2018 succeeded in focusing on emerging issues in the higher education sector in Canada.

Among the key takeaways of the forum were the need for more integrated approach to international recruitment to ensure that students who come to Canada for higher education can not only acquire the desired qualification but are also able to find jobs and integrate themselves into the Canadian economy.

To build upon the success of the forum and to understand the sector from an Indian perspective, Canada India Foundation is planning to organise a similar forum in India in January 2019.

The CIF Higher Education Forum – India will be held in Gandhinagar-Ahmedabad on 16 & 17 January 2019. Several Canadian and Indian educational institutions have already evinced interest in the Indian edition of the Forum.

While the modalities of the Forum including alliances with institutions will be worked out in October 2018, CIF has been assured of continued support by several institutions that were a part of the Canadian Higher Education Forum in July.
