Because, as Canada was gearing up for the Valentine's Day weekend, came the happy news that our Prime Minister, Justin Trudeau, had a chat with India's Prime Minister Narendra Modi, top item on their agenda being a possible supply of Covid19 vaccines to Canada.

Ayurvedic Approach in Febrile Sickness and COVID - 19



Dr. Somendra Mishra, renowned Ayurvedic practitioner and researcher, was the main speakers at the CIF Ayurveda Virtual Speaker series. He presented the findings on how Ayurveda approaches Febrile sickness and COVID-19. While welcoming him to the CIF platform, Satish Thakkar, noted, "Currently, in spite of implementation of prophylactic strategies such as promotion of hygiene, social distancing and global lockdown, the spread of disease remains a challenge. Ayurveda adopts a multi-pronged approach addressing the febrile sickness (Jvara), cough (Kasa) and respiratory distress (Swasa), by improving the patient's immunity, and giving the right diet and herbal supplements etc."

Ontario PC MPP Deepak Anand joined the session as special Guest and was introduced by CIF National Convenor, Ritesh Malik. Anand thanked the CIF team, Harish Verma and other organizers for the sustained campaign to popularize Ayurveda in Canada. He explained his own positive exposure to Ayurveda that took care of a health issue that he faced. "The global Ayurveda market is set to triple from \$3.4 to \$9.7 billion. Why is it. Because of the great products, and also the efforts by people like you in spreading the message of Ayurveda."

Canada Will Likely Get Astra Zeneca Vaccine from India Early



The world's biggest vaccine manufacturer said Monday it would deliver COVID-19 shots from India to Canada "in less than a month", days after a phone call between the two nations' leaders following a diplomatic row over protests by farmers. India -- known as the world's pharmacy -- has stepped up worldwide shipments of the jabs manufactured by the Serum Institute of India, which has emerged as a major player in the fight against coronavirus, as a form of "vaccine diplomacy". The Serum Institute's chief executive said his company was awaiting regulatory approval from Canada. (Read more)


